- Fences are to be constructed with the same materials, specifications, and design as it was originally bult by the Merchant Builder.
- Fences must be capped. See the link below.
- Fences must match existing fence color. (Sherwin Williams Caribou SW3025 stain) Any paint supplier can color match.

# Safety & Security

#### **Security:**

We would like to take this opportunity to inform you of some measures you can take to help mitigate a potential auto burglary.

- Park your vehicle in your garage and keep the garage door closed.
- Always lock your vehicle.
- Keep valuable items stored out of sight or do not store valuable items in your vehicle.
- Above all, remain VIGILANT.

We are considered a low crime area, but we are not immune to crime. You may contact the patrol dispatch 24-hours a day by calling (916) 299-0911. While their presence in the community may act as a deterrent to crime, the Association's patrol officers are not law enforcement. Therefore, to report any crimes or suspected crimes in progress, always immediately contact the Rancho Cordova Police Department at (916) 362-5115 or 911.

#### Mailboxes:

Over the past 6 months some Anatolia Mailboxes have been vandalized throughout the community. While the damaged boxes have been replaced, The Board of Directors and Management are working to install another 20 high security mailboxes throughout the community. If your mailbox is damaged or you see a damaged mailbox as you drive through the community, please call The Clubhouse to let us know right away.

#### **Noise Nuisance:**

The Compliance Team has seen an uptick in all types of noise complaints throughout Anatolia. For compliance to issue a violation we need you to report the issue to Blue Knight Security (916) 299-0911 they are available 24/7. When you report these nuisance noises, they are recorded, time stamped and sent to Management in real time. Once we have the report form security, we can then issue a violation.
